ಸರ್ಕಾರಿ ಪದವಿ ಪೂರ್ವ ಕಾಲೇಜುಗಳ ಉಪನ್ಯಾಸಕರು ಹಾಗೂ ಪ್ರಾಥಮಿಕ ಶಾಲಾ ಮತ್ತು ಪ್ರೌಢ ಶಾಲಾ ಸಹ ಶಿಕ್ಷಕರುಗಳನ್ನು ಬೋಧಕೇತರ ಕಾರ್ಯಗಳಿಗಾಗಿ ಬೇರೆ ಬೇರೆ ಕಛೇರಿಗಳಿಗೆ ನಿಯೋಜಿಸುವುದರಿಂದ ಶಾಲಾ ಕಾಲೇಜುಗಳಲ್ಲಿ ಮಕ್ಕಳ ವಿದ್ಯಾಭ್ಯಾಸಕ್ಕೆ ತುಂಬಲಾರದಷ್ಟು ನಷ್ಟವಾಗುತ್ತದೆ. ವಿದ್ಯಾರ್ಥಿಗಳ ಸಂವಿಧಾನಾತ್ಮಕ ಹಕ್ಕಿಗೆ ಧಕ್ಕೆ ಉಂಟಾಗುತ್ತದೆ ಎಂಬ ಕಾರಣದಿಂದ ಈ ಬಗ್ಗೆ ಹಲವಾರು ಸರ್ಕಾರದ ಆದೇಶ ಹಾಗೂ ಸುತ್ತೋಲೆಗಳನ್ನು ಹೊರಡಿಸಿ ಉಪನ್ಯಾಸಕರ/ಶಿಕ್ಷಕರ ನಿಯೋಜನೆಯನ್ನು ನಿಷೇಧಿಸಲಾಗಿದೆ. ಇದಲ್ಲದೇ ನ್ಯಾಯಾಲಯವು ಈ ಕೆಳಗಿನಂತೆ ತೀರ್ಪು ನೀಡಿವೆ. ಮಾನ್ಯ ಕರ್ನಾಟಕ ಉಚ್ಚ ನ್ಯಾಯಾಲಯವು ರಿಟ್ ಅರ್ಜಿ ಸಂಖ್ಯೆ :13674/2006 ರಲ್ಲಿ ದಿನಾಂಕ :19-12-2006 ರಂದು ಈ ಕೆಳಗಿನಂತೆ ನಿರ್ದೇಶಿಸಿದೆ-

When this Writ Petition came up on 19/12/2006, learned Government Advocate was directed to place on record a statement as to whether any teacher is continuing as Private Secretary to any M.L.A. Though the Government Advocate has not filed the statement, as he received the instructions late, it is submitted by the Government Advocate that only four teachers are now continuing as Private Secretaries to M.L.As./M.Ps./Ministers and that one teacher is on deputation to the Zilla Panchayat, Dharwad. It is also stated that even though the second respondent has written to the authorities concerned, it would appear that necessary orders cancelling the deputation of teachers have not been passed by them. In view of the shortage of teachers to teach the students in the various schools in the state, it is in public interest that deputation of teachers to work in other department is stopped. It is surprising that the direction issued in this regard by the second respondent has not been complied with by some of the authorities.

The second respondent shall also inform the Deputy Commissioners concerned that unless the deputation of the above mentioned teachers is cancelled and compliance is reported, this court will be constrained to initiate appropriate action against the Deputy Commissioners for willful disobedience of the directions of this court.
