Notification of Amendments to Tender Notification

Amendments to the `Tender Document vide Tender Notification bearing no A7/ Tender 01 / 2010-11 dtd 30/10/10 for Printing & Supply of Text Books floated by the Karnataka Text Book Society', are notified as follows . Amendments shall be an integral part of the Tender Document and in all circumstances the Tender shall be implicitly read with all these amendments.

And it is also brought to the notice of all the concerned that the Pre-bid meeting is scheduled at 11.00 am on the stipulated date .

I] Amendment 1

Tender Clause :

2.1.5. The main business of the Legal Entity in the immediately preceding 3 years should be as a printer under Karnataka Sales Tax Act or Karnataka Value Added Tax Act in any state in India. He should be a vendor for printing and supply of textbooks with the Government of Karnataka or any State in India.

2.10 Bid Security (EMD)

2.10.3 The Bid Security shall be returned to the unsuccessful Bidders within a period of eight (8) weeks from the date of announcement of the Successful Bidder. The Bid Security (EMD) submitted by the Successful Bidder shall be held by the KTBS till such time the contract is fully complete and shall be discharged along with the Performance Bank Guarantee.

Amended clause:

2.1.5. The main business of the Legal Entity in the immediately preceding 3 years should be as a printer under Karnataka Sales Tax Act or Karnataka Value Added Tax Act or Local Tax Act in any state in India. He should be a vendor for printing and supply of books/text books with the Government of Karnataka or any State in India.

2.10 BID SECURITY (EMD)

2.10.3 The Bid Security shall be returned to the unsuccessful Bidders within a period of eight (8) weeks from the date of announcement of the Successful Bidder. The Bid Security (EMD) submitted by the Successful Bidder shall be held as Security Deposit by the KTBS till such time the contract is fully complete and shall be discharged along with the Performance Bank Guarantee.

II] Amendment 2

Tender Clause :

3.2 QUALIFICATION CRITERIA FOR EXPERIENCE

3.2.1 For the purpose of qualification a Bidder shall demonstrate experience as in table below:

3.2 QUALIFICATION CRITERIA FOR EXPERIENCE

3.2.1 For the purpose of qualification a Bidder shall demonstrate experience as in table below and the same shall be given in Appendix G-1 :

III] Amendment 3

Tender Clause :

SECTION 8 GENERAL CONDITIONS OF CONTRACT

8.1 DEFINITIONS

(e) "Services" means services other than (c) above and rendered to Block Education Officers in case of Free category books and DDPIs in case of Sale category books and inclusive of transportation, insurance, and any other incidental cost.

(l) ` Block Educational officer` means (Place , Block or Taluk) authority where the free category textbooks is to be supplied

(m) "Deputy Director for Public Instruction" means the DDPI, the authority where the Sale category textbooks are to be supplied.

SECTION 8

GENERAL CONDITIONS OF CONTRACT

8.1 DEFINITIONS

(e) "Services" means services other than (c) above and rendered to Block Education Officers(BEO's) in case of Free category textbooks and Sale category textbooks and inclusive of transportation , insurance and any other incidental cost

(l) ` Block Educational officer` means (Place , Block or Taluk) authority where the free and sale category textbooks are to be supplied

(m) "Deputy Director for Public Instruction" means the DDPI

IV] Amendment 4

Tender Clause :

8.7 INSPECTIONS AND TESTS

8.7.5 The Purchaser's right to inspect, test and, where necessary, reject the school text books after the free text books arrival at Block Education Officer (BEO) office/school level and in respect of Sale books at DDPI office / School level, shall, in no way, be limited or waived by reason of the books having previously been inspected, tested and passed by the Purchaser or its representative.

8.9 Packing

8.9.2 The Supplier at the time of delivery of School Textbooks shall give proper account of supply to the concerned Block Educational Officer / DDPI by bundling the school books in the numbers of 25 or 50 books in each bundle.

8.9.3 The Supplier after the satisfactory delivery of School Text Books to the concerned Blocks/Districts will obtain due acknowledgement from the concerned Block Educational Officer / DDPI and submit the same along with the District-wise Bills for payment. The Supplier shall provide such packing of the School Text Books as is required to prevent their damage or deterioration during transit to their final destination as indicated in the Contract.

8.12. TRANSPORTATION

8.12.1 Where the Supplier is required under the Contract to transport the Free category School Text Books to all 202 BEO's and Sale category Text Books to all 34 DDPIs in Karnataka as shall be

specified in the Contract, it shall be arranged by the Supplier and the related cost including insurance, shall be included in the Contract Price.

Amended Clause :

8.7 INSPECTIONS AND TESTS

8.7.5 The Purchaser's right to inspect, test and, where necessary, reject the school text books after the free text books and sale textbooks arrival at Block Education Officer (BEO) office/school level , shall, in no way, be limited or waived by reason of the books having previously been inspected, tested and passed by the Purchaser or its representative.

8.9 Packing

8.9.2 The Supplier at the time of delivery of School Textbooks shall give proper account of supply to the concerned Block Educational Officer by bundling the school books in the numbers of 25 or 50 books in each bundle.

8.9.3 The Supplier after the satisfactory delivery of School Text Books to the concerned Blocks will obtain due acknowledgement from the concerned Block Educational Officer and submit the same along with the District-wise Bills for payment. The Supplier shall provide such packing of the School Text Books as is required to prevent their damage or deterioration during transit to their final destination as indicated in the Contract.

8.12. TRANSPORTATION

8.12.1 Where the Supplier is required under the Contract to transport the Free category School Text Books and Sale category School textbooks to all 202 BEO's of Karnataka as shall be specified in the Contract, it shall be arranged by the Supplier and the related cost including insurance, shall be included in the Contract Price.

V] Amendment 5

Tender Clause

8.33 GENERAL POINTS TO BE OBSERVED

The Supplier should execute an undertaking in the prescribed form stipulating that he has agreed to the Terms & Conditions mentioned in the tender for submission of Technical & Commercial Bids.

3.The total quantities of SCHOOL BOOKS to be purchased I to X is subject to variation before signing of the contract.

Amended Clause

8.33 GENERAL POINTS TO BE OBSERVED

The Supplier should execute an undertaking in the prescribed form stipulating that he has agreed to the Terms & Conditions mentioned in the tender for submission of Technical & Commercial Bids.

3.The total quantities of SCHOOL BOOKS to be purchased is subject to variation before signing of the contract.

VII] Amendment 6

Tender Clause

8.34 DISCRIPTION OF PACKAGES

Total number of books/titles to be printed are divided into 90 packages. Each package consists of different Titles / Languages / Mediums and different size and colours. The process of arriving at packages has taken into consideration on the basis of the segregation of print work of multi coloured books, two coloured books and black and white books and also on the the size of the books. However there may be combinations in some packages.

8.35 ROYALTY

Royalty to the copyright holder at the rate of 10 paise per each copy of the book published under Free and sale component as per Purchase Order, should be paid to the copyright holder.

Amended Clause

8.34 DISCRIPTION OF PACKAGES

Total number of books/titles to be printed are divided into 90 packages. Each package consists of different Titles / Languages / Mediums and different size and colours . All books shall have multi-coloured cover pages . The process of arriving at packages has taken into consideration on the basis of the segregation of print work of multi coloured books, two coloured books and black and white books and also on the the size of the books. However there may be combinations in some packages.

8.35 ROYALTY

Royalty to the copyright holder at the rate of 10 paise per each copy of the book printed under Free and sale books as per Purchase Order, should be paid to the copyright holder.

Copyright holder is the Managing Director , Karnataka Text Book Society(R) and all rights rests with him .

Other Amendments :

- 1. In the context of the tender where-ever the words ‘ sale category text books shall be supplied to 34 DDPIs’ appear , they shall be substituted with the words , ‘ free and sale category textbooks shall be supplied to the 202 BEOs `**
- 2. Vol 5 – Under Package 72 , Titles under SI no 230 & 231 – 6th Kan FL/Eng SL/Tulu(sem1) & 6th Kan FL/Eng SL/Tulu(sem2) – Deleted**
- 3. Table -1 (Bid Form) – Under condition (1) read ‘ to supply free & sale school books to all the block educational offices in the state ` instead of ‘to supply of school books to all block educational offices & DDPIs in the state `**
