- Hard copies of the downloaded Technical Bid documents of the following firms were placed before the committee for evaluation.
  - a. M/s. Hero Cycles Ltd., Ludhiana,
  - b. M/s. Avon Cycles Ltd., Ludhiana,
  - c. M/s. T.I.Cycles of India, Chennai,
  - d. M/s. S.K. Bikes Pvt. Ltd. Ludhiana.
  - e. M/s. Hero Ecotech Ltd. Ludhiana.
- After verification of the documents uploaded by all the five bidding companies it was found that M/s. T.I.Cycles of India, Chennai , M/s. Hero Cycles Ltd., Ludhiana & M/s. Avon Cycles Ltd., Ludhiana have submitted their bids according to the requirements prescribed in Tender Document. It was also found that M/s. S.K.Bikes Pvt. Ltd., Ludhiana had not produced the Factory License issued by the competent authority and M/s. Hero Ecotech Ltd., Ludhiana has not fulfilled the eligibility criteria (iii).
- The Committee sought to verify whether M/s. S.K.Bikes Pvt. Ltd., has uploaded the factory license & by oversight downloading of the same has been left out or they actually do not possess/uploaded the valid factory license.
- Further, committee also sought to re-verify the documents uploaded by M/s. Hero Ecotech Ltd., Ludhiana and to confirm that all of them are downloaded and put before the committee.
