

The following discussion been taken up in the meeting:-

The supply of free Uniforms under Vidhya Vikas Scheme is planned to reach all students of Govt schools before starting of the academic year. To make success of this programme by delivering the uniforms before commencement of academic year is must. Hence the bidders are selected on the basis of their capability and capacity of manufacturing & supply, As this is a time bound programme of the Government, extending time limit after 90 days is not possible.

It is discussed in the meeting that the tender for supply of uniform cloths to the Government school students of Belgaum division is already late, and it is necessary to take strict action to complete the supply of uniform as early as possible.

Though it is a open tender it is necessary to initiate a clause of restriction to participation of M/s.Suzuki textile co. Ltd., Bhilwara, (Raj) in this tender, as the firm is already been issued a work order of Mysore Division uniform supply for the year 2015-16, vide work order Dated:20.04.2015, from this office, in the interest of timely supply, within prescribed time limit to the Mysore Division, the initiative of this condition in the tender is accepted by all the officers.
