Clarifications are furnished to the queries raised in your above referred letter as follows :

- 1) The stipulations about the number of packages a web offset printer can bid and the number of packages a web offset printer is eligible for work order are set out in part-4 of the RFP. You may bid for all the 71 work packages. For the entitlement is read the clauses in part-4.
- 2) The inspection immediately after the procurement of the paper and post printing stage will not take 20-25 days. So the question of relaxing the 90 days period does not arise.
- 3) An affidavit about the ownership of the machinery as long as the machinery is fixed to the ground in your premises should hold good.
- 4) Yes, there is a discrepancy. Either way it means the bidder should have printed 3 lakh copies of one title or three titles.

Clarifications are furnished to the queries raised in your above referred letter as follows :

- 1) As stated at Sl No 2 of Part 4 of RFP , a web offset printer can quote for all the 71 packages . However a Sheet fed offset printer can quote for lesser number of packages as stipulated in the said clause .
- 2) It is up to the bidder to decide .
- 3) Not advisable .
- 4) As the Government has not received the benefit of such a certificate in the past , no such certificate will be issued .
- 5) It is up to the bidder to take the risk . However it is not in the interest of the government to differentiate .
- 6) You will be considered as one entity ie Web Offset printer . You have to pay EMD applicable for Web Offset printer .
