## NOTIFICATION

**No. DPAR 21 SDE 2007, Bangalore, dated: 21<sup>st</sup> May, 2008**

Whereas the draft of the following rules further to amend the Karnataka Civil Services (Classification, Control and Appeal) Rules, 1957, was published as required by clause (a), Sub-section (2) of Section 3 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) in Notification No. DPAR 21 SDE 2007, dated 17.4.2008 in part-IVA (No. 403) of the Karnataka Gazette Extra-ordinary dated 22.4.2008, inviting objections and suggestions from all persons likely to be affected thereby within fifteen days from the date of its publication in the Official Gazette.

Whereas, the said Gazette was made available to the public on 22.4.2008.

And whereas no objections and suggestions have been received in this behalf by the State Government.

Now therefore, in exercise of the powers conferred by Sub-section (1) of Section 3 read with Section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) the Government of Karnataka hereby makes the following rules, namely :-

## RULES

**1. Title and Commencement:-** (1) These rules may be called the Karnataka Civil Services (Classification, Control and Appeal) (28<sup>th</sup> Amendment) Rules, 2008.

(2) They shall come into force from the date of their publication in the Official Gazette.

**2. Amendment of Schedule II.**- In the Karnataka Civil Services (Classification, Control and Appeal) Rules, 1957, in Schedule II, under the heading "Department of Public Instruction", under sub-heading "Tutorial Cadre Posts", for the entries relating to the category of post of Non graduate Head Master in Model Higher Primary schools, Headmasters in Higher Primary schools, primary Assistant Masters, Music teachers in Primary School, Drawing Teachers in Primary School, Physical Education Teachers in Primary School, Shikshana Samyojarkaru (Primary), the following shall be substituted, namely:-
