NOTIFICATION

The draft of the following rules further to amend the Karnataka Recruitment of Gazetted Probationers (Appointment by Competitive Examinations) Rules, 1997 which the Government of Karnataka proposes to make in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) is hereby published as required by clause (a) of sub-section (2) of section 3 of the said Act, for the information of persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration after fifteen days from the date of its publication in the Official Gazette.

Any objection and suggestion which may be received by the State Government from any person with respect to the said draft before the expiry of the period specified above will be considered by the State Government. DRAFT RULES


1. Title and commencement. - (1) These rules may be called the Karnataka Recruitment of Gazetted Probationers (Appointment by Competitive Examinations) (5th Amendment) Rules, 2009.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Amendment of Schedule II. - In the Schedule II to the Karnataka Recruitment of Gazetted Probationers (Appointment by Competitive Examinations) Rules, 1997-

(i) under "C-Personality Test" in Section I, for the words "five times the number of candidates," "three times the number of candidates" shall be substituted.
